I understand that BCR Participation carries with it certain inherent risks that cannot be eliminated completely ranging from minor injuries to catastrophic injuries including death. I waive any claims for injuries that I sustain, including death, and agree to hold harmless and indemnify the Law Enforcement Torch Run, Special Olympics, Bull Canyon Run organizers, its directors and officers, employees and volunteers, suppliers, contractors, sponsors, the City of Santa Maria, the County of San Luis Obispo, County of Santa Barbara, the State of California, and anyone connected with the race. I agree that the race may use any photographs taken of me without compensation. I have read and understand all of this. I am making this agreement and paying my entry fee in exchange for the privilege of running this race and using the facilities provided by the race.
